2012 Holiday Motorcoach Traffic Regulations

Special regulations and additional parking areas are in effect from November 16, 2012 to January 2, 2013 to improve tour and charter bus operations and maintain traffic flow during the holiday season.

Buses bringing parties to Manhattan core (Rockefeller Center and Radio City Music Hall) locations must not park or layover in the core. Buses must drop off passengers and immediately withdraw to private off-street parking or to the limited on-street peripheral areas (see below and reverse side for map). Buses should return to the core at the scheduled departure time and wait in "No Parking", "No Standing", or "No Standing except Trucks Loading & Unloading" zones for no more than 20 minutes (15 minutes for Rockefeller Center and Radio City Music Hall) for passengers to rejoin the bus.

Radio City Music Hall Special Instructions: Buses should drop-off passengers on the **N/S of 51 St between 5 & 6 Aves and the S/S of 50 St between 6 Ave & Rockefeller Plaza.**

At the drop-off point, the driver will be given a voucher specifying the pick-up time and location after the show.

Buses must comply with New York City regulations prohibiting engine idling. If the temperature is 40°F or above, no idling is permitted. If the temperature drops below 40°F, idling is permitted only for three minutes. Buses must not park in City bus stops, at fire hydrants, and in crosswalks or driveways. Buses must not double park.

Use Service Rd west of 11 Ave between 39-34 Sts

▪ **Rockefeller Center and Radio City Music Hall:**

Pick-Up with vouchers only, see paragraph above.

DESIGNATED BUS ROUTES TO/FROM MIDTOWN WAITING AREAS

- 29 St (9-12 Aves) ▪ 34 St ▪ 42 St
- 49 St (12-6 Aves) ▪ 50 St (6-12 Aves)
- 57 St ▪ 66 St

Note: Buses should use designated Truck Routes to and from pick-up and Drop-Off areas.

PERMITTED RIVER CROSSINGS

- All river crossings except Brooklyn Bridge

PROHIBITED PICK-UP/DROP-OFF AREAS

- 49 St & 50 St (east of 8 Ave)
- 5 Ave, 32-59 Sts

PROHIBITED STREETS

- Brooklyn Bridge
- Harlem River Drive
- FDR Drive (north bound prohibited, north of 23 St)
- FDR Drive (south bound prohibited, 116-15 Sts)
- Park Ave (north of 42 St)
- Park Ave Viaduct around Grand Central Terminal
- Henry Hudson Pkwy
- Central Park Drives (except transverse roads)

Note: Permit required for bus use of parkways, call NYC Department of Transportation at 718/433-3317.
