NYC VCP Cleanup Plan Remedial Activities to Begin

The New York City Office of Environmental Remediation (OER) is providing this Fact Sheet pursuant to the New York City Voluntary Cleanup Program (VCP). OER has approved the Remedial Action Work Plan (RAWP) submitted by Mr. Rehan Perveez for 61-63 North 6th Street, Brooklyn, New York (Block 2325, Lot 27 & 28). The remedial work will begin in November 2014. The RAWP can be reviewed electronically or in person at the document repositories identified in the box at left.

Site Description:

The 7,500 square-foot site is currently vacant parking lot, containing a one-story cargo-container in the southeastern portion. The proposed future use of the Site will be 2 one-story commercial buildings with full cellars.

Summary of the Remedy:

The remedial action for 61-63 North 6th Street is a Track 1 Unrestricted Use cleanup. The specific elements of the proposed remedial action include:

- Preparation of a Community Protection Statement and performance of all required NYC VCP citizen participation activities according to an approved Citizen Participation Plan;
- Performance of a Community Air Monitoring Program for particulates and volatile organic carbon compounds;
- Selection of NYSDEC 6NYCRR Part 375 Table 6.8 (a) Track 1 Unrestricted Use Soil Cleanup Objectives (SCOs);
- Excavation and removal of soil/fill exceeding Track 1 Unrestricted Use SCOs. The footprint of the new building will be excavated 11 feet below grade for the building's cellar level. Approximately 5,400 tons of soil will be excavated and removed from Site;
- Transportation and off-site disposal of all soil/fill material at permitted facilities in accordance with applicable laws and regulations for handling, transport and disposal of contaminated soil;
- Collection and analysis of four endpoint samples to determine if the remedy meets SCOs;
- Submission of a Remedial Action Report (RAR) that describes the remedial activities and certifies that the remedial requirements have been achieved and lists any changes from this RAWP.

If Track 1 Cleanup is not achieved, the following construction elements implemented (as part of new development) will constitute Engineering and Institutional Controls:

- As part of new development, installation and operation of a passive Sub-Slab Depressurization System (SSDS);
- As part of new development, installation of a vapor barrier system below the concrete slab underneath the building slabs and behind foundation walls;
- As part of new development, construction of a composite cover system consisting of 6" concrete building slab to prevent human exposure to residual soil/fill remaining under the Site;
- Submission of an approved Site Management Plan (SMP) in the RAR for long-term management of residual fill, including certification of Engineering and Institutional Controls and reporting at a specified frequency; and
- Continued registration with E designation for the property.

Cleanup activities has started and are expected take approximately three months to complete.

Next Steps: After the enrollee completes the remedial work, a RAR will be prepared and submitted to OER. The RAR will describe the cleanup activities and certify that all cleanup requirements were met. Once the RAR is approved, OER will issue a Notice of Completion, a City liability release, and a New York City Green Property Certificate. OER will then issue a fact sheet announcing the completion of the remedial action and identify all engineering and institutional controls to be used at the Site.

Figure 1: Site Location




Figure 2: Site Map
