The New York City Office of Environmental Remediation (OER) provides this Fact Sheet pursuant to New York City's Voluntary Cleanup Program (VCP). An application has been submitted by Paulding Avenue Realty LLC for enrollment of the property located at 3985-3989 White Plains Road in the northern section of Bronx, New York and identified as Block 4827, Lots 3 into the VCP. The Remedial Investigation Report (RIR) details the results of an environmental investigation at the site including the nature and extent of contamination. The draft Remedial Action Work Plan (RAWP) proposes remedial actions to address contamination delineated in the RIR.

Public Comments on the RAWP

OER is accepting public comments on the draft RAWP for 30 days until January 24, 2014. The RIR and draft RAWP are available for review at the document repositories identified in the box on the left including a public library branch and through a link to OER's website. Comments should be sent to Mr. Shaminder Chawla via mail or e-mail (see contact information at left).

Site Description

The Site is 5,980-square feet and is currently a vacant lot. The proposed future use of the Site will consist of a one story commercial building with two retail units and a cellar.

Summary of RIR

The environmental investigation identified areas of potential impacts from an inactive AST that has been properly removed from the site. Two VOCs and several metals were found above standards in soil samples. Groundwater was not investigated due to refusal. Soil vapor samples showed low concentrations of petroleum related and chlorinated VOCs.

Summary of the Remedy

The specific elements of the proposed remedial action include:

- Preparation of a Community Protection Statement and performance of all required NYC VCP Citizen Participation activities according to an approved Citizen Participation Plan;
- Implement a Community Air Monitoring Plan for particulates and volatile organic carbon (VOCs) compounds;
- Establish Unrestricted Use Track 1 Soil Cleanup Objectives (SCOs);
- Excavation and removal of soil/fill exceeding SCOs. For development purposed, entire site will be excavated to a depth of 10 feet for the new building's cellar. Approximately 3,300 tons of soil will be removed;
- Transportation and off-Site disposal of all soil/fill material at permitted facilities in accordance with applicable laws and regulations for handling, transport, and disposal, and this plan. Sampling and analysis of excavated media as required by disposal facilities. Appropriate segregation of excavated media onsite;
- Collection and analysis of end-point samples to determine the performance of the remedy with respect to attainment of SCOs;
- Submission of a Remedial Action Report (RAR) that describes the remedial activities, certifies that the remedial requirements have been achieved, defines the Site boundaries, and describes all Engineering and Institutional Controls to be implemented at the Site, and lists any changes from the RAWP;

If Track 1 Unrestricted Use SCOs are not achieved, the following elements will be implemented as part of new construction and will act as Engineering Controls:

- Installation of a vapor barrier/waterproofing system beneath the building slab and behind the foundation side walls;
- Construction and maintenance of an engineered composite cover consisting of a building slab; and
- Submission of an approved Site Management Plan (SMP) in the RAR for long-term management of residual contamination, including plans for operation, maintenance, monitoring, inspection and certification of Engineering and Institutional Controls and reporting at a specified frequency.

Next Steps

OER will review the draft RAWP and consider all public comments submitted during the comment period before it approves a final RAWP. The approved RAWP will be placed in the public library branch and on OER's website and a second fact sheet will be issued before remedial work begins.
